## APPLICATION FOR MEMBERSHIP

The Society comprises the Abingdon Symphony Orchestra and the Abingdon Choral Society. Applications are welcome for membership of the orchestra or the choir. There are no formal auditions, but admission to the orchestra depends on there being a vacancy for the instrument in question and on the player's experience. Prospective new members are welcome to attend for a trial period of up to one month before subscriptions are due. They will be entitled to a £15 reduction on the membership fee for the first year. Members are entitled to take part in all the society's activities and are expected to abide by the Society's Constitution.

Friends of ADMS are entitled to free admission and programme for all concerts and to attend the AGM & social functions.

Joint membership for 2 Members and/or Friends from the same family will earn a £5 discount.
